
You can take up to 30 minutes from your shift to complete your THA. Answer only the questions you want, but the more questions you answer the more personalized your THA will be.

HOW TO COMPLETE YOUR TOTAL HEALTH ASSESSMENT

- 1. Go to kp.org/hwf
- 2. Click on the link to start your total health assessment
- 3. Sign on to kp.org. If you don't have a user ID and password, you'll need to register to create them.
- 4. After signing on, you'll be directed to the HealthMedia® website. Choose the Succeed™ session. Just look for the sunflower.
- 5. Click "Go."

FREQUENTLY ASKED QUESTIONS

Q. Is my health information from the total health assessment (THA) and healthy lifestyles programs kept confidential?

A. Yes. **Your personal health information is kept confidential.** Kaiser Permanente, your employer, will not receive your individual results from the total health assessment or healthy lifestyle programs. This information is held by HealthMedia, a third-party vendor.

Q. Do I need to answer all of the questions on the Total Health Assessment?

A. No. Answer only the questions you want, but the more questions you answer the more personalized your THA will be.

Q. Will my employer know if I have activated a kp.org account?

A. No. Your employer will not know if you have activated a kp.org account. You can activate a kp.org account only if you are a Kaiser Permanente member.

Q. What is the total health assessment?

A. The total health assessment, or HealthMedia® Succeed®, can help you understand how your behavior affects your health. It asks you a series of questions about yourself and the way you live. After you complete the questionnaire, the program uses your answers to create a personalized action plan with steps you can take to improve your health.

Q. Can I used paid time to complete my total health assessment?

A. You are allowed up to 30 minutes during your normal shift to complete your THA. **Please schedule an appropriate time with your manager prior to taking your THA**.

Q. What information do I need in order to complete the total health assessment?

A. While taking the total health assessment, you'll be asked for the following information:

- Weight and Height
- Waist measurement
- Blood pressure (within the past 12 months)
- Total cholesterol (within the past 5 years)
- HDL cholesterol (within the past 5 years)
- LDL cholesterol (within the past 5 years)
- Triglycerides (within the past 5 years)
- Blood glucose (blood sugar)
- Immunization history

Having this information on hand will help you complete the assessment more quickly. (Kaiser Permanente members can view most lab test results, immunizations, and past office visit information via My Health Manager at kp.org.) If you don't have this information, you can still complete the assessment, but your action plan will be less personalized.

Q. Can I share the results of my total health assessment with my health care team?

A. If you're a KP member, you may choose whether or not to attach the results of your assessment to your electronic health record, which will make them available to your Kaiser Permanente health care team.

Q. Can I claim the \$50 as a tax-deductible donation?

A. No. The donation will be made by KP, so you cannot claim it as a donation on your income tax return.

Q. What are the charitable organizations that have been selected for the Take and Give campaign?

A. Kaiser Permanente Community Benefit has awarded two organizations with a two-year grant for contributions resulting from eligible employees and physicians taking the total health assessment in 2010 and 2011. Wholesome Wave, focuses on increasing access to healthy, fresh, and affordable locally grown food. The National Assembly on School-Based Health Care (NASBHC), focuses on supporting the oral health needs of schoolchildren.
